The Peoples Bancorp Foundation, Inc. was organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to non-profit organizations that also qualify as Section 501(c)(3) exempt organizations and are located in Peoples Bank, National Association's principal assessment areas in Ohio, West Virginia, and Kentucky. The Foundation seeks to enhance the quality of life for individuals served by organizations located in the communities served by Peoples Bank. Foundation contributions will be used to meet the needs of all segments of our community – especially low- and moderate-income households, businesses and neighborhoods – to enhance the non-profit organizations' community service functions and to enhance the century old core values established by Peoples Bank and its affiliates.

The Foundation focuses its charitable giving in four major areas:

1. Community Investment and Economic Development;
2. Youth and Education;
3. Human Services programs that improve the social needs of low- and moderate-income communities and individuals; and
4. Arts and Culture.

Applying For a Grant

Peoples Bancorp Foundation, Inc. will review applications for grants 4 times a year. Grants should be in writing with the required completed application and supporting documentation requested. Each application shall be reviewed by the Foundation very carefully.

Our next schedule meeting will be in October 2010. Please submit applications by October 1st. If the application is not received by that date, it will be held over for consideration during the next grant period.

Applicants should allow 60 to 90 days for processing and response.

Grant Requests Must Include:

- A completed application form;
- An IRS letter of 501(C) 3 determination;
- Narrative description as noted on application form;
- A list of board members of applying agency;
- A one page budget if applicable;
- Key members involved with project and their qualifications;
- Any pertinent publications or brochures.

If you have not been determined a tax-exempt organization under 501(C)3, please include a copy of your application for exempt status.
